PART I GENERAL EXPECTATIONS

Bowie Elementary agrees to implement the following statutory requirements:

- Consistent with section 1116, Bowie Elementary School will work to ensure that the required school level parental involvement policies meet the requirements of section 1116 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1116(d) (2) of the ESSA.

PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS

1. Bowie Elementary School will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1116 (c) (1) (2) of the ESSA:
 - *meetings with Site-Based Decision Making Committee held twice in the Fall and twice in the Spring to review and revise the policy*
2. Bowie Elementary School will take the following actions to involve parents in the process of school review and improvement under section 1116 (c) (1) (2) of the ESSA:
 - *For the 23-24 year, LCISD will send out a Parent Involvement Survey that will provide insight on convenient times for parents to attend and share their valuable input when reviewing and revising the policy.*
 - *Site base meeting (parent, teacher and administration) once a month*
 - *Electronic options and suggestions form for families*
3. Bowie Elementary School will hold an annual meeting to inform parents of the school’s participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend by:

- *Notifying parents ahead of time to plan so they can attend one of the meeting dates.*
 - *Expressing the importance of parent input needed at these meetings.*
 - *Sharing the benefits that Title I program has for each child.*
 - *providing ESL support to students and parents.*
4. Bowie Elementary School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
- sharing the information during the Annual Title I Meeting and Open House*
 - *sharing the information during parent conferences*
 - sharing the information during Curriculum Nights*
 - *sharing the information in Skyward and Canvas*
 - sharing the information in School Website*
5. Bowie Elementary School will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
- meeting with parents, sending home emails, mail, call outs in English and Spanish and Canvas*
6. Bowie Elementary School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
- student's reports will be accessible in Skyward family access.*
 - parents will have access to their student's state assessment results in the Texas Assessment Student Portal at texasassessment.gov*
7. Bowie Elementary School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph at the Title I parent meeting and the STAAR information meeting--
- the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:
- *parent Conferences, aiding parents about student's progress*
 - *parent engagement nights will be offered in the Fall and Spring*
8. Bowie Elementary School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement by:

- *providing information on how to access and utilize Skyward and Canvas*
- *providing training based on parents' needs.*

9. Bowie Elementary School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- *providing training and staff development meeting regarding parent involvement and meaningful partnership.*

10. Bowie Elementary School will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- *The information related to the student is shared with the parents through our school website, Skylert bilingual call outs, emails, Newsletters, BES on Twitter and/or Facebook, and/or marquee.*

11. Bowie Elementary School will provide events such as curriculum events, informational events, celebrations, and conferences.

ADOPTION

This School Parental Involvement Policy has been developed jointly with, and agreed on with, parents of children participating in Title I, Part A programs, as evidenced by the principal and BES parents. This policy was adopted by Bowie Elementary School on October 11, 2023, and will be in effect for the 22-23 school year.
