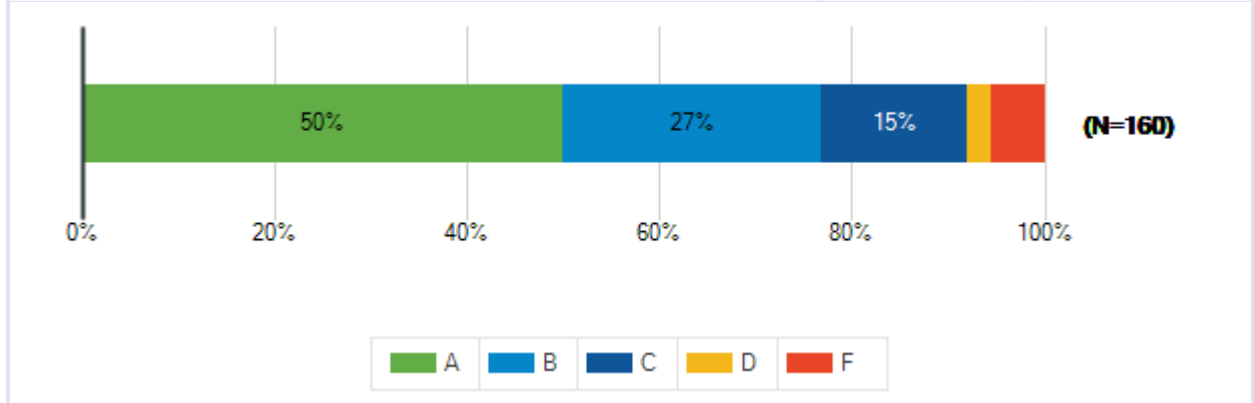

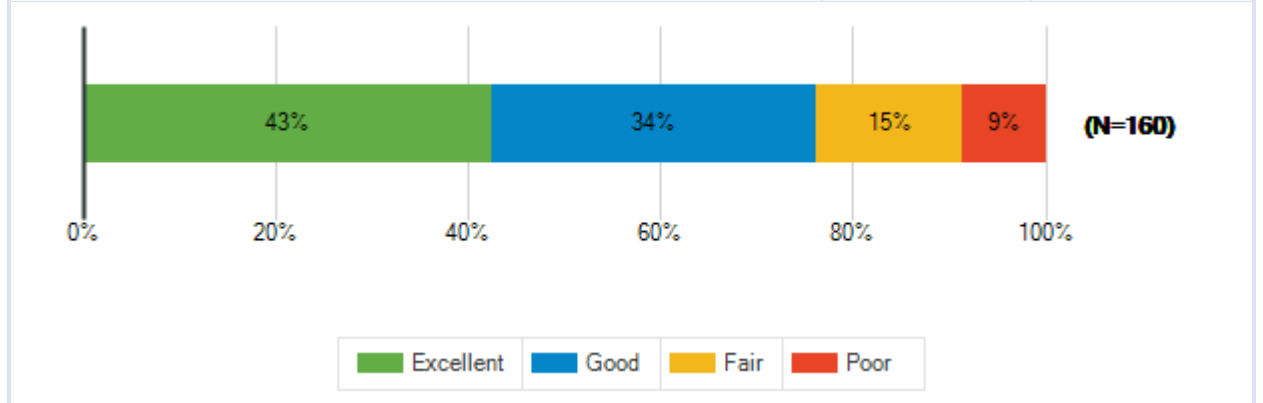

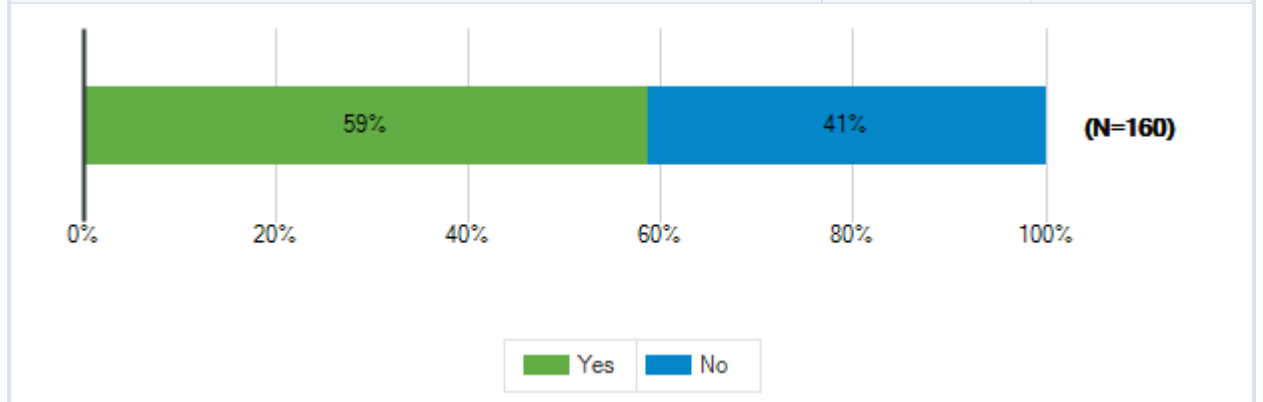
Overall, how would you rate how Lamar CISD handled the COVID-19 pandemic for the 2020-2021 school year?

Has your child participated in virtual learning during the 2020-2021 school year?

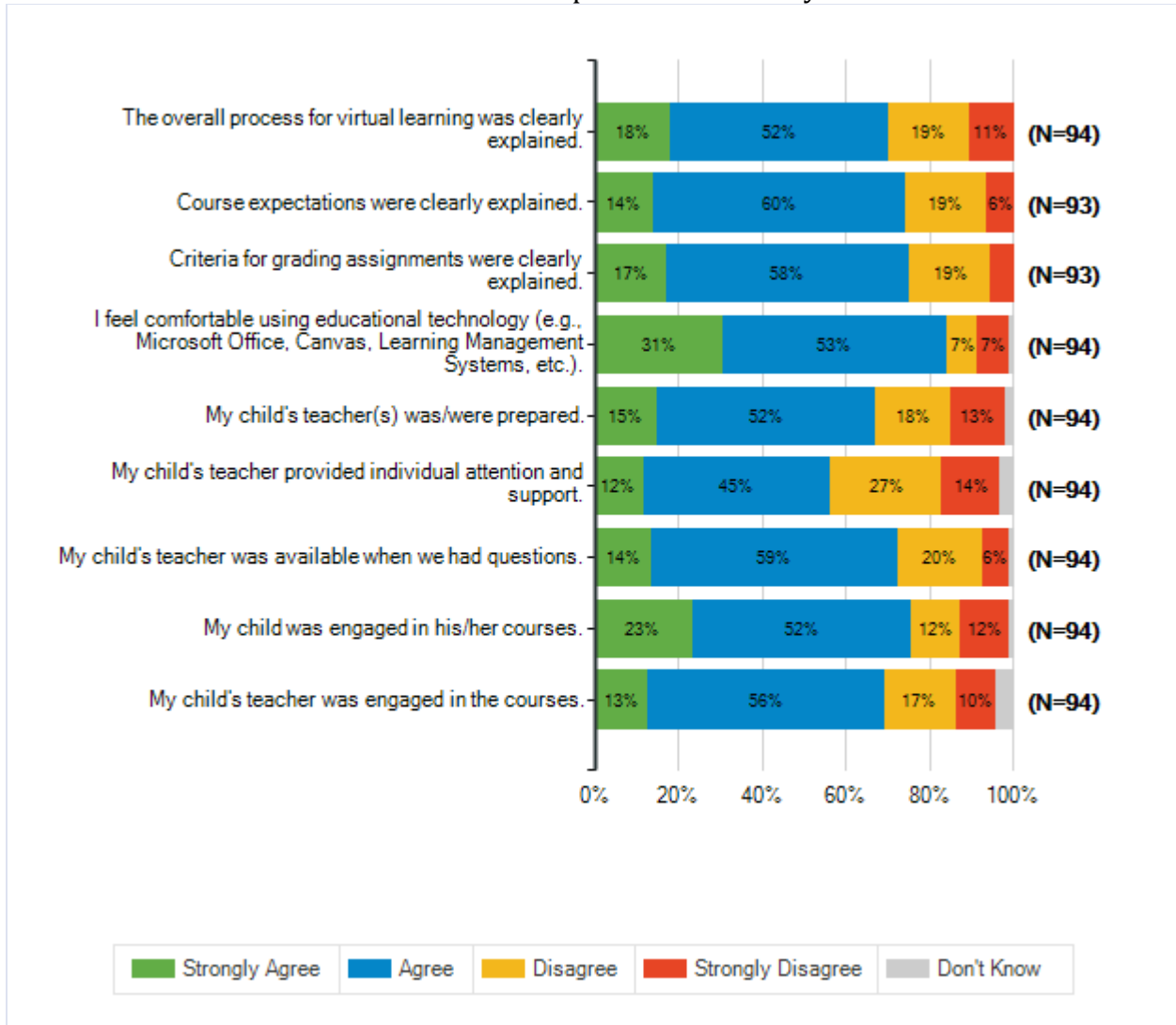

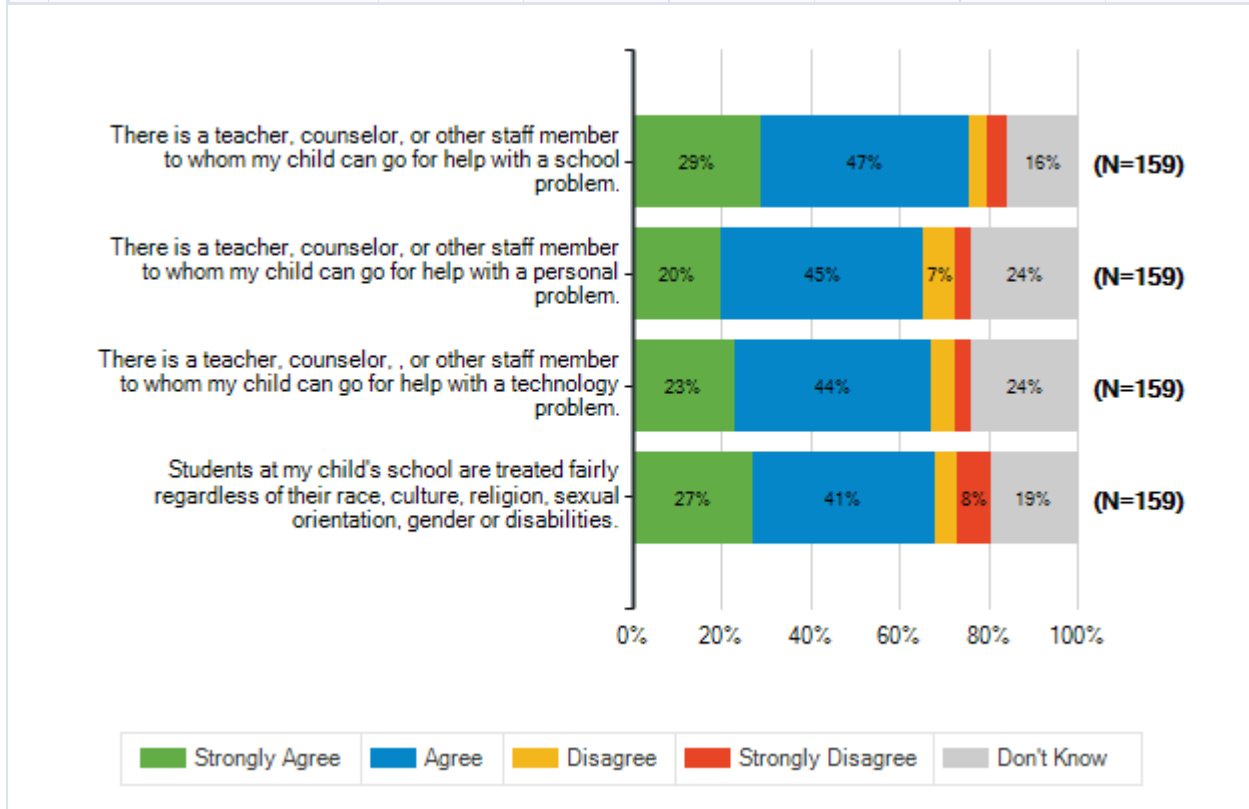

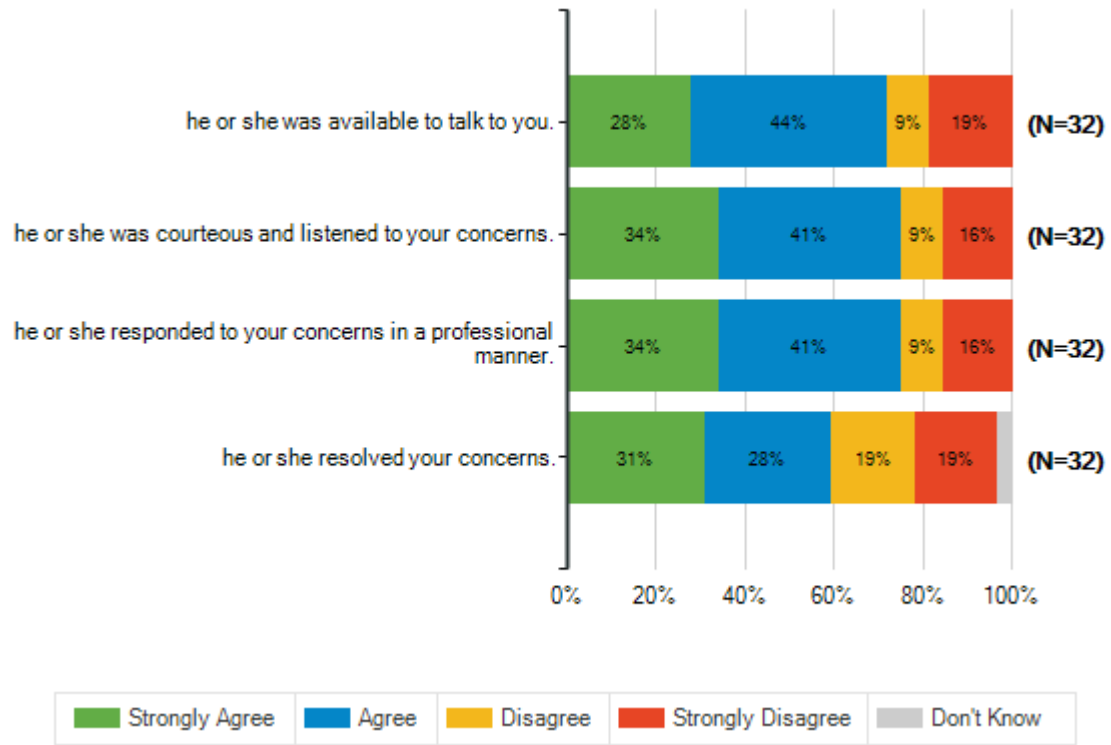

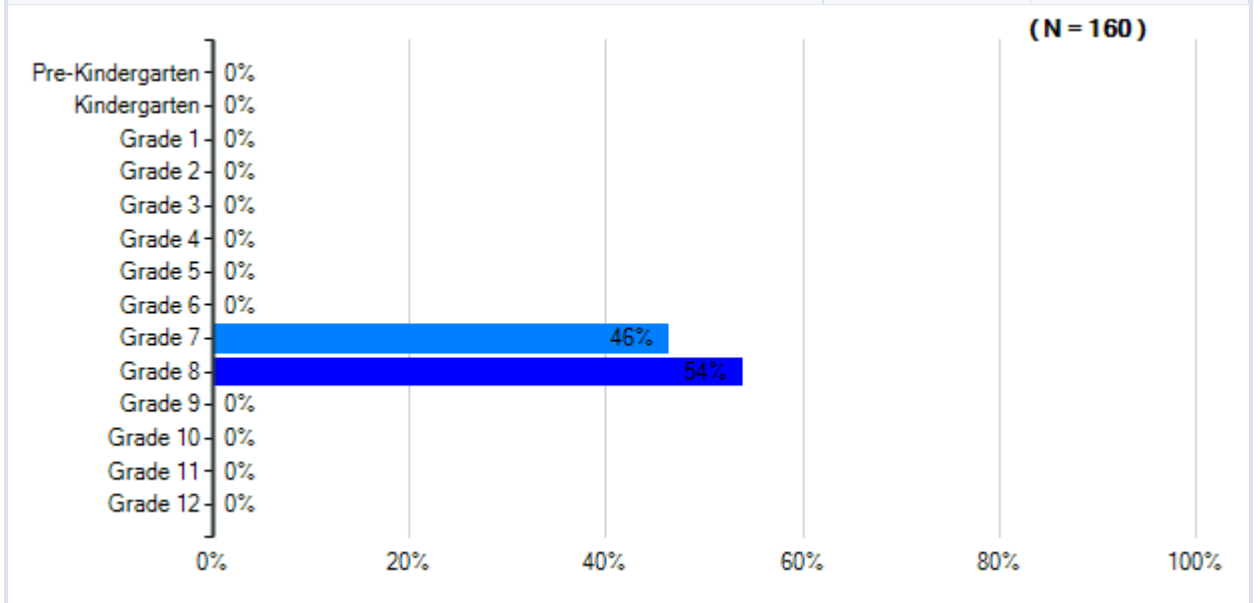

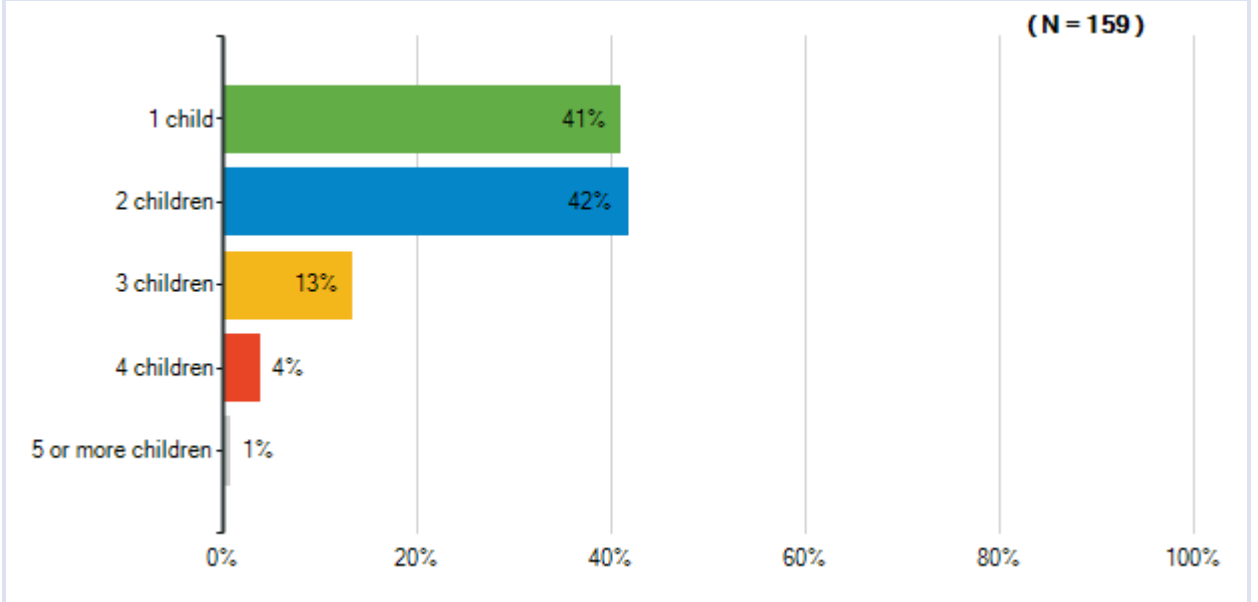

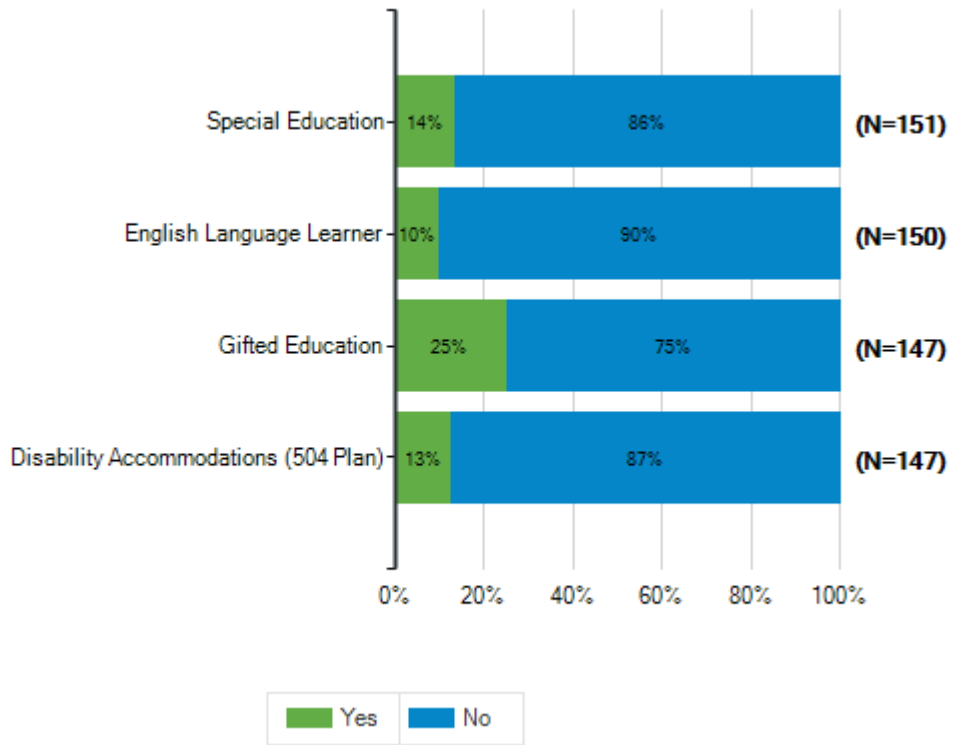

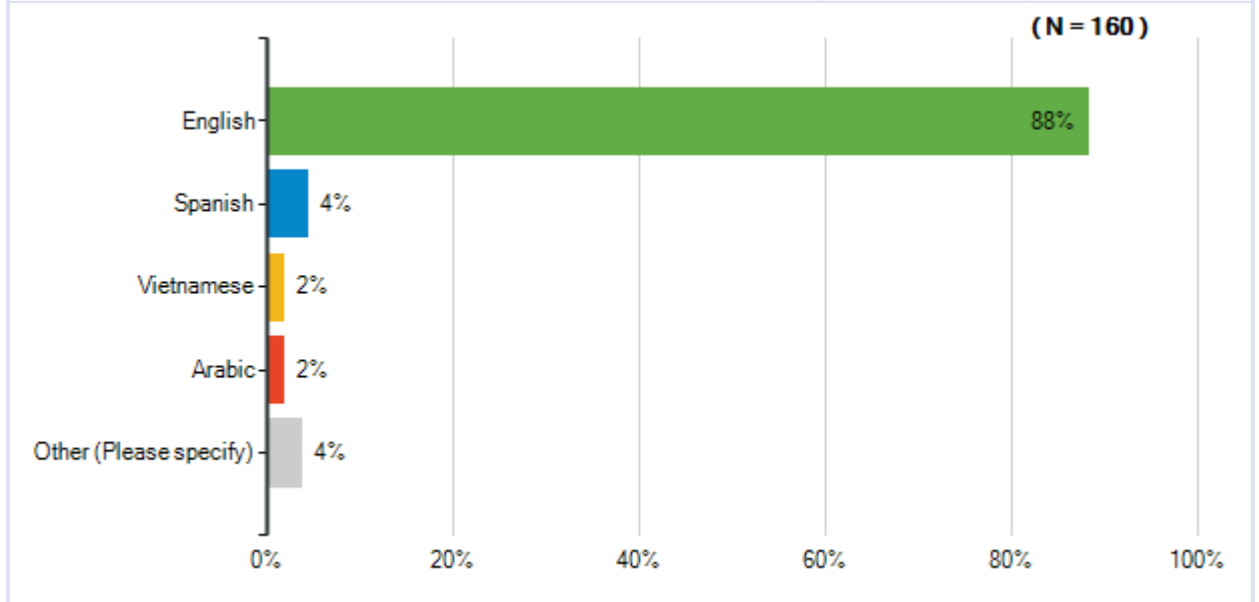

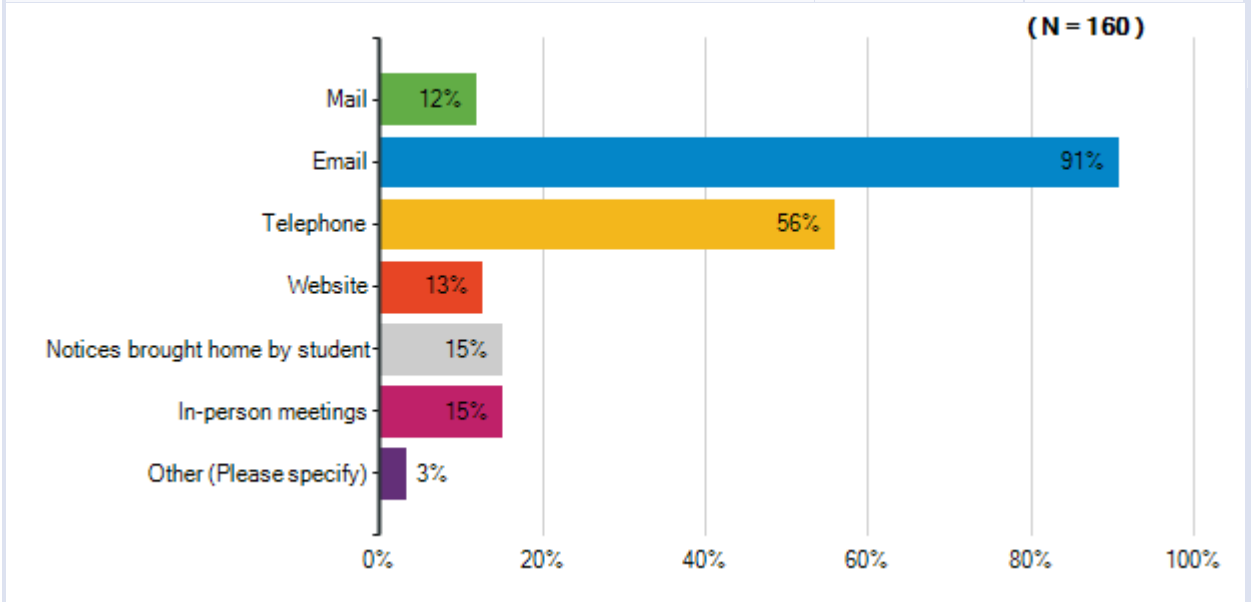
