



Title I, Part A Parent and Family Engagement Policy **for Travis Elementary School**

PART I. GENERAL EXPECTATIONS

Travis Elementary agrees to implement the following statutory requirements:

- Consistent with section 1116, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1116 of the ESSA, and each include, as a component, a school-parent compact consistent with section 1116(d)(2) of the ESSA.

(C) that parents are full partners in their child’s education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;

(D) the carrying out of other activities, such as those described in section 1116 (d)(2) of the ESSA.

PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS

1. **Travis will** take the following actions to involve parents in the joint development of its school parental involvement plan under section 1116 (c) (1) (2) of the ESSA:
 - a. *For 2024-25 year, LCISD will send out a Parent Involvement Survey (Holdsworth).*
2. **Travis will** take the following actions to involve parents in the process of school review and improvement under section 1116 (c) (1) (2) of the ESSA:
 - a. *Site base meetings (parent, teacher and administration)*
3. **Travis will** hold an annual meeting to inform parents of the school’s participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
 - a. *Holding an annual meeting to share the benefits that the Title I program has for each child.*
4. **Travis will** provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school’s curriculum, the forms of academic assessment used to measure children’s progress, and the proficiency levels students are expected to meet by:

- a. *sharing the information during the annual Title I meeting*
 - b. *sharing the information in Skyward*
5. **Travis** will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - a. *meeting with parents, sending home emails, mail or bilingual call outs*
6. **Travis** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - a. *student's reports will be sent home by mail and the parents will be able to access the report in Skyward as well.*
7. **Travis** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph:
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and how to work with educators:
 - a. *parent Conferences, aiding parents about student's progress*
8. **Travis** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - a. *Offering computer training for Skyward, signing up for free Office 365, Canvas and providing additional training based on the parents' needs*
9. **Travis** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - a. *Providing training and staff development meetings regarding parent involvement and meaningful partnership.*
10. **Travis** will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - a. *The information related to the student is shared with the parents through our school website, Skylert bilingual call outs, email, Newsletters, Twitter and/or Facebook, logging into our LCISD Skyward account and marquee.*

PART III. ADOPTION

This School Parental Involvement Policy has been developed jointly with, and agreed on with, parents of children participating in Title I, Part A programs, as evidenced by SBMT.

This policy was adopted by **Travis** on October 24, 2024 and will be in effect for the period of **2024-2025**. The school will distribute this policy to all parents of participating Title I, Part A children on or before November 1, 2024.
