

Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

The Lamar CISD (Navarro Middle School) agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). 1. - B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children’s academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
- Campus will host parent activities throughout the year to assist parents
 - District will explore having a parent resource center
- C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
- Professional development will be provided for staff
 - PAC committees will discuss ways to work together more effectively
- D. - Information sent home would be in both English and Spanish
- Information will be posted on the campus and district website
- Promote the use of district call out systems for parent engagement on campuses
- NMS will maintain a Facebook page for news
- Campus Newsletter sent frequently
