

Carter Elementary Grandfathering Guidelines

All current 4th-grade students living in planning units 44H, 44I, 44J, 44M and 44P will be allowed to declare which elementary campus they will attend for the 2018-2019 school year—Carter Elementary or their current elementary campus—via our “grandfathering” process.

All elementary students—and all younger siblings—living in planning unit 44G on or before Thursday, February 15, 2018 will be allowed to remain at Velasquez Elementary—via our “grandfathering” process.

Transportation will not be provided to any “grandfathered” student.

No action is necessary for students who will attend the school to which they are zoned.

The "grandfathering" application will be available in the front offices of Thomas, Velasquez and Williams elementary schools or online at www.lcisd.org beginning March 5, 2018. All "grandfathering" applications must be completed and returned to the Executive Director of Elementary Education no later than April 20, 2018.

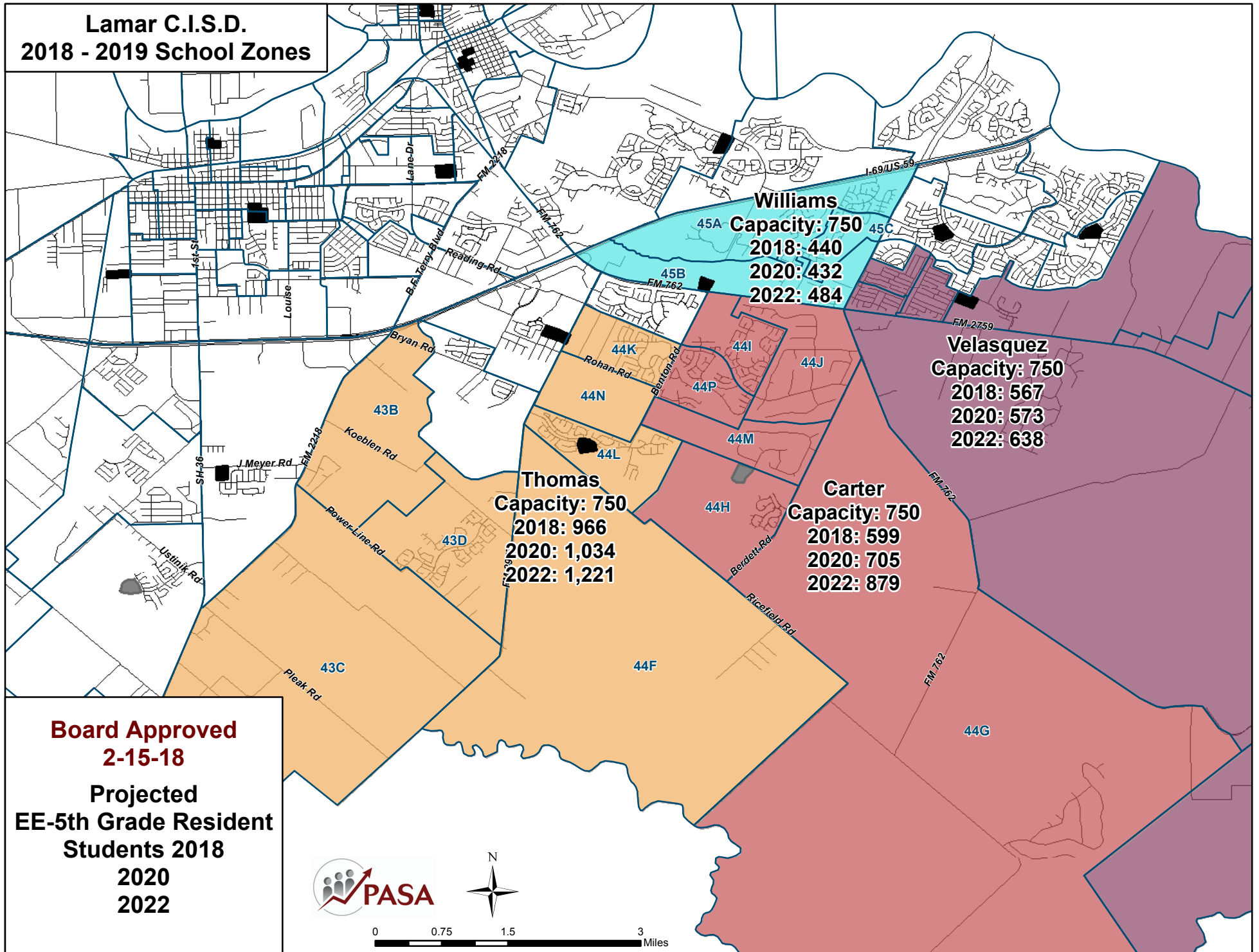
