BEFORE ME, the undersigned authority, personally appeared Kathryn Kaminski, known to me to be the person whose name is subscribed to this Affidavit, and who, upon first being duly sworn by me, did under oath depose and say:

1. My name is Kathryn Kaminski. I am more than 18 years old, and have never been convicted of a felony. I am of sound mind and I am fully competent to give this affidavit under oath. The facts contained within this affidavit are within my personal knowledge and are true and correct.
 2. I am a member of the Board of Trustees (District 1) in the Lamar Consolidated Independent School District (LCISD).
 3. As a local public official of LCISD, I have a substantial interest in a business entity, as that term is defined in Local Government Code Sections 171.001-171.002, that would experience a special economic effect distinguishable from its effect on the public by a vote or decision of the LCISD Board of Trustees.
 4. The business entity is Zgakam Corporation, doing business as Gingerbread House Learning Center (hereinafter "Gingerbread House"), 2417 Fourth Street Rosenberg, Texas 77471. I am President of this business entity; own more than ten percent of the shares of voting stock of this business entity; own more than ten percent and more than \$15,000 of the fair market value of this business entity; and I have received funds from this business entity that exceed ten percent of my gross income for the previous year.
 5. My husband, Larry Kaminski also has a substantial business interest in this business entity as that term is defined in Local Government Code Sections 171.001-171.002.
 6.
